Furthermore, an application is received from BAS department for submission as Part - time scholars have done all requisite conditions, but because the clauses is not fitting for early submission.

Accordingly, the committee after discussion placed the proposal, which is placed in ANNEXURE 32.03.

Decision: Approved and the corrected clause is:

Existing clause Proposed clause The minimum period of residential requirement a) The minimum period for completion of for study and research at the institute from the course work is 1(one) semester from the date date of registration to the date of submission of of registration for all categories of PhD thesis shall be 36 months(P.G. students) and 60 students. In addition, minimum period of months (B.E/B. Tech students). A candidate is thesis submission will be as per point (b). normally expected to submit his/her thesis within b) The minimum period of thesis submission five years (P.G. students) and seven years shall be 30 months for all categories of PhD (B.E/B. Tech students) from the date of students (enrolled with P.G. degree) and 60 registration. This period may be extended by the months (enrolled with B.E/B. Tech degree) Senate as a special case @ 06 months at a time to from the date of registration. However, a maximum of five years (P.G. students) and maximum period for submission should not seven years (B.E/B. Tech students) from the date exceed five years (enrolled with P.G. degree) of registration after which the registration shall and seven years (enrolled with B.E/B. Tech stand cancelled. degree) from the date of registration. Delay beyond the stipulated period of submission may be extended by the Senate as a special case @ 06 months at a time to a maximum of 2 years (Enrolled with P.G. degree) and 3 years (enrolled with B.E/B. degree) after which the registration shall stand cancelled.

And this modified clause will be applicable for all existing enrolled scholars.

- d) PEC should try to club the training/internship with BTP.

- a) Such internship will not be allowed for department having theory classes in 8th semester
- b) At any cost students should not compromise with academic activities,
- c) Since Bachelor of Technology Project (BTP) is fully governed by the Project Evaluation Committee (PEC) of respective departments, hence it is the same committee which is fully responsible to permit or not permit for such training leading to job provided point (b) should be compliance.
