Seeking app lockdown	roval for changing academic calendar for session Jan-June 2020 due to prevailing			
	Keeping in view the nationwide lockdown due to pandemic of COVID-19 a revised academic calendar is prepared where few changes are included such as prepone of summer vacation, re-scheduling of end semester exam, conduct of summer course etc,. The revised academic calendar is placed in ANNEXURE 24.02 .			
Decision	(i) Revised academic calendar as proposed for the period Jan-June 2020 was approved. Summer vacation for faculty shall be from 15 th April in phase wis for one month only. HoDs of concerned department shall prepare the roster for faculty willing to avail summer vacation in phase wise of respective departments.			
	(ii) As granting of EL or any leave related matters do not come under the purview of the Senate and that Senate is the highest academic body, the matter of granting EL to faculty members during summer vacation shall be administratively taken up as per existing rules. Registrar may appraise accordingly to faculty members of the Institute.

Note	As advertisement for new Ph.D. has already been floated, it was also proposed include B.Tech degree holder for direct admission to Ph.D program with the			
	 following conditions: Bachelor's degree in Engineering or Technology or equivalent in any disciplin with a minimum CGPA of 7.0 out of 10 or minimum of 70 % of marks. Candidates must have valid GATE score to avail institute fellowship. Final year students completing his/her degree by July 2020 are also eligible 			
	apply. 4. They have to complete minimum of 6 (six) theory courses, Research Methodology being one of the compulsory subjects.

	(ii) The Senate opined that with valid GATE Score card only, the students admitted in PhD can avail institute fellowship. The Committee further recommended to formulate appropriate rules and regulations in this regard.

Seeking app	roval for In-house Summer Internship (ISI) for NIT AP
Note	In view of this pandemic situation, and keeping in view of availability of enough hardware and software equipment at department level, it is proposed to allow students internship at Institute level. Moreover, students from other institutes are also encouraged to undertake summer internship. Such shortlisted students may be paid Rs 5,000/- each under TEQIP-III (REFER TO ANNEXURE 24.04)
	Senate may consider and approve the proposal
Decision	Senate has approved the proposal with following observations:
	In house summer internship may be conducted in place of compulsory industrial training for 6 th semester students. The 4 th semester students may take up start-up projects, project based on present situation etc. For 2 nd semester students activities like Ek Bharat Shreshtl Bharat (EBSB) may be conducted. These programmes may be conducted in parallel with summer courses during the period as given in academic calendar.
