ELIGIBILITY CRITERIA

- 2. The bidder must possess valid Public transport vehicle licensed and registered under in any of the states in India. The duly registered valid document shall be submitted.
- 3. The participants must possess up to date fitness certificate of vehicles and driving license. Certificate of fitness/similar document shall be submitted.
- 4. Participants should have technically trained manpower and should have bulk of equipments to be utilized for the said activities.
