### **Duties & Responsibilities of Counseling Cell:**

The counseling cell shall also to take immediate necessary action for conducting some programmes pertaining to counseling which may be within the broad areas as stated above during the forthcoming induction programmes.

The counseling cell shall have to submit a report of activities at fortnightly interval to the Director for further necessary action.

The counseling cell constituted vide this notification shall remain valid for a period of 2 (two) years or any further order, whichever is earlier.
