Extension of the tenure of engagement of the Chartered Accountants firm

The Chartered Accountants firm M/s Romen Sarma & Co, Guwahati was engaged after completing due formalities for carrying out Accounting works of the Institute for two year w.e.f 03.01.2019 on approval of 21st BoG held on 19/11/2018. The tenure of engagement of the firm will over on 02.01.2021and the same may be renewed for a further period on satisfactory performance as per the Agreement executed on 03/01/2019.

Moreover, in NIT Arunachal Pradesh there are no permanent Group A staff with finance back ground to handle the matters pertaining to finance and accounts and presently one Deputy Registrar from IIT Guwahati on deputation is looking after the activities pertaining to finance & account, whose term of deputation shall likely to be completed shortly.

In view of above since the performance of Chartered Accountants firm M/s Romen Sarma & Co, Guwahati is highly satisfactory, it is proposed to extend the engagement of the said firm for an another period of 2 (two) years in the interest of the Institute. Further, due to lack of experienced & qualified staff in the area of Finance & Accounts in the Institute, the firm may also be entrusted the responsibility to carry out and maintenance of day to day accounts of the Institute.

FC may consider and recommend the same.

Decision of the Finance Committee

The Finance Committee RECOMMENDED extension of the tenure of the Chartered Accountants firm M/s Romen Sarma & Co, Guwahati from 03.01.21 to 02.01.22 for carrying out accounting works of the Institute. After extension of one year, the total tenure of the firm will be three years, hence fresh expression of interest is to be floated for the accounting work before the completion of the tenure of the present firm.
